



Important Notice for Broker/Dealers

First Investors Funds announces online access to fund accounts and quarterly statements

Effective July 1, 2009, online access to First Investors Fund accounts and quarterly dealer copy statements will be available to the broker/dealer community via the firstinvestors.com website. In addition, after the second quarter (June 30th) mailing of dealer copy quarterly statements, we will discontinue our practice of printing and mailing dealer copy statements. Representatives are being alerted to these changes via a letter mailed with their second quarter dealer copy statements. (Please see reverse side for a copy of this letter.)

Branch Managers and Home Office employees are eligible for online access as well. They should visit our website, www.firstinvestors.com, to learn more about getting online account access. Establishing a user ID can be done online and only takes a few minutes.

Effective July 1, 2009, online access to your clients' First Investors Fund accounts and quarterly dealer copy statements will be available to the broker/dealer community via the firstinvestors.com website. In addition, after the second quarter (June 30th) mailing of your dealer copy quarterly statements, we will discontinue our practice of printing and mailing dealer copy statements. At this time, we encourage you to visit our website to sign up for online access so that you can begin viewing your clients' First Investors fund accounts and will be ready when First Investors' "goes paperless" in the 3rd quarter.

How to Get Started:

- To get account access, go to www.firstinvestors.com, and click on the "*Broker/Dealer Access*" link.
- Next, click on the "*Need to Register?*" link and enter the 4-digit dealer number that corresponds to your Broker/Dealer firm. Your B/D Number can be found in the upper right hand portion of your quarterly statement. Click on "*Continue*". Please verify your firm name before entering your personal information.
- Next, create and input a user ID in the User Name field and enter your full name in the "Real Name" field. Select a User access level (Home Office, Branch Manager, or Representative) in the Type field, select a password and then confirm the password, enter your e-mail address and phone number, and enter your branch and representative numbers, then click "*Continue*". Review all of the information and then click "*Register*".
- Print out the online registration form and have it signed by an authorized signer from your firm, with a Medallion Signature Guarantee stamp and mail the completed form to our home office.
- When the completed form is processed at our home office, you will be notified via e-mail that your registration was received and access has been approved.

Again, the second quarter 2009 dealer copy statements will be the last paper statements mailed to you. All 2009 dealer copy statements will be available for viewing on our website.
